Anticipating an explosion in the security market, <u>LINKBYNET</u> announces the acquisition of <u>Securiview</u>, reinforcing one of its four strategic pillars in addition to Cloud, Software and DevOps.

As a Managed Security Services Provider (MSSP), <u>Securiview</u> was a pioneer since 2006 in operating its Security Operating Center (SOC), and with its full range of services around Operational Security (SecOps). Its SOC activities have also passed ISO 27001 certification, making Securiview the first certified player in this market. Then, Securiview obtained the very selective qualification PASSI (Information System Security Audit Provider) issued by ANSSI (National Agency for Information Systems Security) at the beginning of 2017 and continued its approach towards qualifications. PRIS (Security Incident Response Provider) and PDIS (Security Incident Detection Provider).
